We, the undersigned, the President and the Secretary, respectively, of the Atascadero Art Club, an existing unincorporated association, do hereby subscribe our names hereto, having been first directed by the members of said club, for the purpose of forming a non-profit corporation under the General Non-profit Corporation Law of the State of California, and we do hereby certify:

I

That the name of the existing unincorporated association which is being incorporated, is the Atascadero Art Club, and that the name of the corporation shall be Atascadero Art Club, Inc.

II

That the specific and primary purpose for which it is formed is as follows:

This Club shall be non-profit and is organized as a cultural group whose aims are to promote love and appreciation of art, museum pieces and historical data; to foster and encourage young artists; to cooperate with other Civic organizations in promoting Civic pride and activities for the beautification of Atascadero and surrounding area; to promote and encourage the establishment and maintenance of suitable quarters for preserving and showing of works of art, museum pieces and historical data for public benefit, said quarters, its contents and the activities and holdings of this corporation to be perpetuated as a community project, whereby no individual shall ever gain possession of any such works of art, museum pieces or historical data belonging to this club, for personal gain. The club shall be for the mutual benefit of any and all persons who are interested in art in its varied forms and in the promotion of the purposes herein stated.
